## Project: CEN Norm on controller professional figure

You may remember Giorgio Cinciripini´s presentation and proposal for a project on the CEN norm of the controller profession. The proposal did not find enough support. However, he continued to work on the idea and clarified the process to establish a CEN norm. Please read his current update:

The main activities are:

- after the translation of the UNI 11618 (up to Assocontroller) in English, the "pre-working team" would have to agree to a common version to be officially sent to CEN. How much work? I've made some of my own forecasts to arrange the work. I think that in less one month ( 3 to 4 people) can be efficiently done
- the other most critical step is 'synchronize' the proactive contacts by IGC members in 13 countries (+ Italy) to their own local CEN Members requesting to be part of the proposed opening Technical Group on Controllers. Of course timing and details will be provided at the proper time. I cannot foresee any time allocation for this activity: it's more political.
- the activity of Technical Group after the official opening (normally is physical) would be minimal thanks to the above agreement. Maybe, there will be more normalization's technical matter . that will be followed by the chairman.

Mr. Salerio (UNI) strongly recommends having a meeting with IGC and/or potential members of the workgroup to explain the logic and framework. This pre condition is essential to avoid unsuccessful project!

We could see two options:

- a 3 hours meeting in Milano, guest of UNI
- a presentation during the Assembly 2020

#### 4.) Literature Review

The success stories of Amazon, Google, AirB&B, Zalando and many other Internet start-ups have brought the topic of start-ups into the focus of managers and investors. In the resulting euphoria, however, most founders neglect the topic of controlling, either partially or even completely. Yet both the short phases of their life cycle and the explosive growth of young companies make the topic of controlling for start-ups all the more urgent. Even established companies have been increasingly launching their own start-up initiatives in recent years (e.g. innovation labs, accelerators, incubators, hubs and corporate venture capital), of course without having any experience in controlling them. The current literature review recommends three distinguished books on this important subject (members only).
